

Responsible Use of Technology: Conduct Agreement

Form 140-1 Students / Parents - Guardians

Wolf Creek Public Schools encourages the responsible and purposeful use of contemporary digital tools in our schools to assist with instruction and learning. Therefore, all students within Wolf Creek Public Schools (WCPS) are eligible to access a wide variety of WCPS supported digital tools and services to support their learning as they complete their education in Wolf Creek.

A detailed **Responsible Use of Technology: Conduct Agreement** ([source link](#)) outlines and articulates the responsibilities of all members and stakeholders within WCPS in regards to the purposeful use of digital technologies. Parents, guardians, and/or students need to acknowledge they have read and understand this Conduct Agreement before access can be provided to WCPS network or collection of digital services and resources. Wolf Creek Public Schools encourages parents and guardians to be actively involved in knowing about their son/daughter/ward's online activities and credentials to various digital technologies.

Access to digital services and resources are provided through Windows based and cloud based services via a student log in. The services that students have access to include a Wolf Creek Public Schools email account as this serves as the username for other digital tools and resources that are often hosted on the Internet (like Tumblebooks, MyBlueprint, Hapara Workspaces, Discovery Education, etc.). Many teachers will also include educational activities during the learning day using various online educational digital resources designed to meet the curricular goals of a grade level or subject area.

Students are prepared to access online tools and learning environments through specific instruction in Digital Citizenship. This is reviewed as an ongoing process as students move from grade to grade in order to emphasize responsible online behaviour. Despite our best technical efforts to block offensive, inappropriate, suggestive, or otherwise concerning digital messages or content, students and staff may still potentially come across material on the web which is inappropriate within a learning context. Through our district approach to proactively teaching Digital Citizenship, students are taught to exercise regular and appropriate caution before engaging in any kind of online communication, sharing, or searching for information. Specific instruction is provided around not sharing personal information over the Internet through school or home based technologies.

To be granted access to Wolf Creek's suite of digital tools and resources, the principal of the student's school and their parent / guardian must be satisfied that the student understands the Responsible Use of Technology: Conduct Agreement and related school or WCPS policies around acceptable and responsible conduct. Teachers will review the Conduct Agreement with their students and we encourage parents/guardians to also review this information with their children.
